

# Hoërskool PAREL VALLEI High School 2018



At the annual meeting of parents held on 18 September 2017, the compulsory school fee agreed upon by the majority of parents present is **R30 397.00 for Gr8 and R29 597.00 for all other grades per annum for 2018**. *Tydens die jaarlikse vergadering van ouers wat op 18 September 2017 plaasgevind het, is daar deur die meerderheid van die ouers besluit op verpligte skoolgeld van R30 397.00 vir Gr8 en R29 597 vir alle ander grade per jaar vir 2018.*

## TERMS AND CONDITIONS / BEPALINGS EN VOORWAARDES

- Both parents are responsible for the payment of school fees. *Beide ouers is verantwoordelik vir die betaling van skoolgeld.*
- School fees are payable **in advance**. A concession is made to pay in monthly installments from January to November. Should any installment be outstanding by the due date, the full outstanding annual school fee shall immediately become due and payable. *Skoolgeld is vooruitbetaalbaar. 'n Vergunning word gemaak om maandelikse betalings van Januarie tot November te maak. Indien enige betaling teen die betaaldatum onbetaal is, sal die volle uitstaande jaarlikse skoolgeld onmiddelik betaalbaar word.*
- In terms of the Schools' Act (Section 39) parents who need financial relief may apply for relief. Applications must be addressed to the Chairman of the School Governing Body and should reach the school no later than 28 February 2018. *Ingevolge die Skolewet (Artikel 39) mag hulpbehoewende ouers aansoek doen om verligting van skoolgeld. Aansoeke hiervoor moet gerig word aan Die Voorsitter van die Beheerliggaam en moet die skool teen 28 Februarie 2018 bereik*
- Should the compulsory school fees not be paid, you may be prosecuted in terms of Section 41 of the S.A. Schools' Act. Costs incurred by such action will be for your account. *Indien die verpligte skoolfonds nie betaal word nie, mag u ingevolge Artikel 41 van die Skolewet vervolgd word. Enige kostes as gevolg van hierdie aksie sal vir u rekening wees.*
- Should your payment of school fees fall into arrears, the School Governing Body will levy interest up to the level of the prime bank rate. *Sou u betaling van skoolgeld agterstallig raak, sal die Beheerliggaam rente hef tot op die vlak van die prima uitleenkoers.*
- Accounts will be sent electronically. *Rekening sal elektronies gestuur word.*
- Should your child leave or start at Parel Vallei during the year, you will be liable for the full term in which your child's enrolls / leaves. *Indien u kind gedurende die jaar Parel Vallei verlaat of begin, sal u verantwoordelik wees vir die volle kwartaal se betaling.*
